#### **MEETING MINUTES**

#### **CALL TO ORDER**

The quarterly meeting was called to order at approximately 5:00p.m. by the chair, Emerson Wiles. Trustees in attendance were Emerson Wiles, chair, Sara Coppola, Dwana Doctor, and Dawn Winn. Also in attendance was Chrissy Cook, Branch Manager of the Hampton County Library, Carol Dingle, Branch Manager of the Estill Public Library, Abigail Barna-Ashley, Interim Director and Sena Loyd, Regional Director of the AHJ Public Library System.

#### **APPROVAL OF MINUTES**

### **Estill Public Library**

# Hoopla

Hoopla launce in January 2025. Since the launch date, 57 patrons created an account and borrowed a total of 127 items. The average cost per circulation is: \$2.21.

# **Sprinter Van Grant**

The \$50,000 Impact Grant through the Institute of Museum and Library Services was officially approved after initial conditional approval with the requirement of grant revision. Abigail Barna-Ashley has an upcoming meeting to review retailer options.

# **Annual Survey**

An Annual Survey for each individual county and the regional system was completed and submitted evaluating our statistics for the previous FY. Highlights of the survey included an increase in adult registered users, library visits and program attendance.

# **Personnel Update**

Carol Dingle was hired as a full-time branch manager at the Estill Library after serving as Interim Branch Manager.

#### **OLD BUSINESS:**

Hampton County Board Accounts – Discussion included details about current bylaws and the need for a co-signer on the Hampton County bank accounts. Members discussed the responsibilities of bank signers and procedural requirements before the notion was put to a vote. The motion passed to add Emerson Wiles, Hampton County Board Chair, as a co-signer to the bank accounts managed by the Hampton County Board.

**Board Member Appointment Process** – The board member appointment process was reviewed with board members discussing the processes they went through to become a member of the Hampton County Library Board. There was agreement that further investigation is needed to ensure all Hampton County Library Board members are properly appointed.
